Short Title

1. This order in council may be cited as the *Administrative Arrangements Amendment Order (No. 1) 2025*.

PUBLIC SERVICE DEPARTMENTAL ARRANGEMENTS
NOTICE (No.1) 2025

Preliminary

Short Title

1. This notice may be cited as the *Public Service Departmental Arrangements Notice (No. 1) 2025*.

Commencement

2. This notice commences on 4 April 2025.

Authority and purpose

3. This notice is made under sections 197 and 198 of the *Public Sector Act 2022*.

Part A – Establishment and declaration of government entity

4. That part of the department of government listed in Column 1 of the Schedule is established as a government entity and declared to be part of the department listed in Column 2 of the Schedule.

Part B – Government entity amalgamated with, and declared to be part of, a department

5. The government entity established under clause 4 of this notice listed in Column 1 of the Schedule is amalgamated with, and declared to be part of, the department of government listed in Column 3 of the Schedule.
